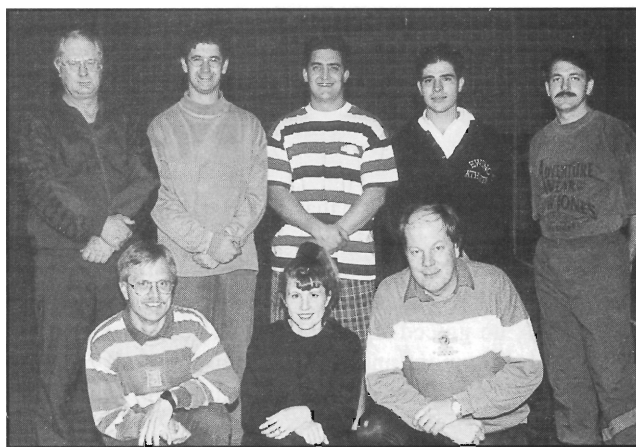

## JOHANNESBURG

### Pupils

During the first half of 1995, 36 pupils underwent pupillage at Johannesburg. Of these 31 wrote the examination and 22 passed. During the second half of 1995, 35 pupils have been admitted as pupil members.

### Arbitration initiative

Talk of the town at the Johannesburg Bar is the special general meeting at which the arbitration and consultation initiative was given the go-ahead. The arbitration initiative envisages the setting up of an arbitration facility which would provide the consumer with a full range of arbitration services including the provision of an arbitrator, premises in which to conduct the arbitration, recording and typing facilities, and even an appeal procedure. It is envisaged that members of the Bar would serve on a panel of potential arbitrators, and consumers would be able to select from them the arbitrator of their choice. The consultation initiative envisages the provision of consultation rooms outside of the city centre where members of the Bar would be able to consult with attorneys and clients without having to travel to the city centre to do this, and without having to cause a domestic imposition. The consultation rooms are not regarded as second chambers, and specific rules have been put in place to avoid them becoming such.
