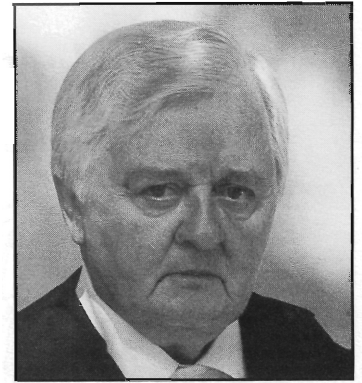
Hoofregter van Venda aangestel tot met sy terugkeer na Kimberley.
