Hendrik van der Linde SC

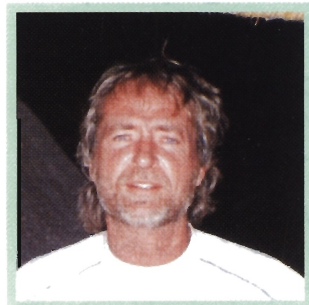

Shyam Gyanda SC

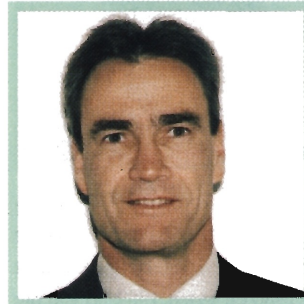
