Function

In the light of the fact that parliament has not found the time in the past seven years to discharge its constitutionally-imposed duty to rationalise the superior courts, it is extraordinary that it should have time to tamper with the sitting arrangements of a court which issued fewer than 300 items of civil process last year.

Bar news

Accommodation

By the end of June more than two-thirds of the members of the Johannesburg Bar will be in Sandton. The common room in the CBD closed for lunches on 18 May. At present only snacks, tea and coffee are served. As regards the library, it was resolved at a general meeting on 3 May that there would be two libraries, one in Sandton and the other in the CBD. Both will be equipped in a manner which fairly addresses the requirements of the members who will practise in the two centres. The library committee will be responsible for the allocation of resources towards funding for acquisitions and maintenance. This is subject, again, to the approval by the Bar Council. This was the last time (after 40 years) that a general meeting would be held in the common room.

Pupils

A question which arose, and will have to be addressed by the GCB Examination Board, is whether pupils should in future be allowed to "write" their examinations electronically.
