**Clarise Kruger LLB (NMMU).** Clarise commenced her pupillage in January 2007 soon after having graduated from university and became a member on 14 December 2007.

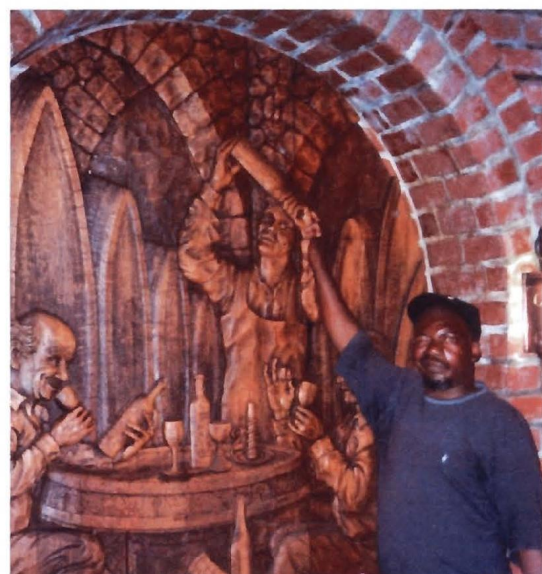
### New pupils

After considering about fifteen applications, six new pupils have been accepted. They have the following profiles: two black males, one black female, two white females and one white male.

The pupillage programme for the Eastern

Cape has been adapted to the extent that six pupil-mentoring groups have been established, comprising members from all levels of seniority at the Bar. The aim of the adapted programme is two-fold: first, to lessen the burden of pupillage on members in a small Bar, and secondly, and perhaps more importantly, it is hoped that the pupils themselves will benefit from a far broader range of experience than to which they would otherwise have access. It is further hoped that given the shortage of junior work, the adapted programme will present the pupils with a greater exposure to attorneys.
