#### Changing of the guard

The Eastern Cape Society of Advocates mourns the death of its most senior junior member, Stuart James Redpath, who died on 23 May 2013. He was admitted on 1 May 1980 and was a member of the Attorney General's staff in Grahamstown until he commenced private practice in Grahamstown on 1 December 1990. His career path mirrored that of his father, Herman Frederick Redpath, who after having been admitted as an advocate in Pietermaritzburg enjoyed an illustrious career as a member of the Attorney General's staff in Grahamstown before commencing private practice in Grahamstown on 11 April 1975. His membership of the Eastern Cape Society

of Advocates ceased at the end of October 1975, but he contributed valuable and frequent service until the mid-1980s by serving as an assessor in the criminal courts. Stuart passes on the baton to his daughter, Nicola Redpath, who was admitted on 6 March 2003 in Grahamstown where she commenced private practice on 1 July 2003. Nicola has altered the Redpath pattern slightly by contributing her services more than once as an acting magistrate in Grahamstown.

Her daughter Lily, at the tender age of one year, has spent a little time in the common room as something of an honorary member. She demonstrates all the attributes

of a pupil in the wings, perfecting the art of a low tackle on the ankles of selected junior members and an eye for a decent set of car-keys.

The Society has great expectations of her becoming the fourth member of the Redpath family to hold chambers in Grahamstown.
